

Application for an IFTA Licence and Decals

International Fuel Tax Agreement (IFTA)

This form is intended for carriers that, under the International Fuel Tax Agreement (IFTA), are required to obtain a licence and decals for their qualified motor vehicles. It can be used to apply for a licence and decals or for the reinstatement of a revoked, cancelled or suspended licence.

- has two axles and a gross weight (or registered gross weight) of more than 11,797 kg (26,000 lbs); or
 - is used with another vehicle and their combined weight is more than 11,797 kg (26,000 lbs).

A **qualified motor vehicle** is a motor vehicle that is used in the course of commercial activities to provide interprovincial or international passenger or goods transportation services and that:

• has three or more axles, regardless of weight;

You must obtain a pair of decals for **each** qualified motor vehicle. However, you need only one licence for your **entire fleet** of vehicles.

Information

Signature

This form must be signed by the applicant, if he or she is an individual. Otherwise, it must be signed by one of the following people authorized to sign on behalf of the applicant:

- a member (in the case of a partnership)
- the president, vice-president, secretary or treasurer (in the case of a corporation)
- a trustee (in the case of a trust)

It can also be signed by the authorized representative of any of the people named above, in which case the representative must enclose one of the following documents with the application (if he or she has not already done so):

- a power of attorney
- a duly completed copy of form MR-69-V, *Power of Attorney, Authorization to Communicate Information, or Revocation*
- a resolution by the board of directors

Payment

Enclose with the application a cheque or money order (in Canadian dollars and dated the day of the application) made payable to the Minister of Revenue of Québec and bearing the applicant's IFTA number. **The amount of the cheque or money order must be the same as the amount shown on the "Total amount payable" line.** Do not enclose any other payment to Revenu Québec with this application.

Allow two to four weeks for processing. The licence and decals will be mailed to you.

Reinstatement of a revoked, suspended or cancelled licence

If you are applying to have a revoked, suspended or cancelled licence reinstated and new decals issued, you must have filed all your quarterly returns and paid any fuel tax, penalties or interest owing, as well as the licence reinstatement fee.

You must enter the applicant's IFTA number on the form.
